Adult (WA only): \$30/year or \$80 for 3 years. Adult members receive Northwest Chess via periodicals mail each month. WCF state membership included.

Junior (WA only): \$24/year or \$43 for 2 years. Junior members also receive Northwest Chess each month. Must be under age 21 at time of expiration. WCF state membership included.

Senior: \$25/year or \$65 for 3 years. Senior members also receive Northwest Chess each month. Must be age 65 or over. WCF state membership included if applicable.

Scholastic (WA only): \$14 for 6 months. Same as junior membership, except for 6 months only. Can be converted to a regular junior membership by paying the balance before expiration.

Family (WA only): \$10/year, \$18 for 2 years (with \$43 junior primary membership) or \$25 for 3 years

(not a subscription — membership only). This class of membership is open only to co-residents of an Adult, Senior or Junior member. Expires at the same time. If first member is a junior, additional family member(s) must also be juniors.

Subscriber (U.S. only): \$30/year or \$80 for 3-years. For clubs and organizations or for persons living outside the Northwest (WA). Subscribers receive Northwest Chess each month, but no memberships are included. Inquire about special rates for libraries and school chess clubs.

Subscriber (Foreign): US\$40/year (Canada) or US\$60/year (all other countries); no discounts are available. Subscribers receive Northwest Chess each month, but no memberships are included.
